## GREATER SHEPPARTON CITY COUNCIL

### NOTICE OF PROPOSAL TO DISCONTINUE PART OF ANDREW FAIRLEY AVENUE, SHEPPARTON

At its meeting on 18 March 2014, Greater Shepparton City Council (“**Council**”) resolved to give public notice under Section 206 and Clause 3 of Schedule 10 of the *Local Government Act 1989* (“**Act**”) that it proposes to discontinue the part of Andrew Fairley Avenue which is shown cross-hatched on the plan below (“**the Road**”).

If the Road is discontinued, Council proposes to sell it to SPC Ardmona Limited (“**SPCA**”) or a company related to SPCA.

A person may make a submission on the proposal. All submissions will be considered in accordance with section 223 of the *Local Government Act 1989*.

Only submissions received by Council by midnight on Thursday, 22 May 2014 will be considered.

Please note that Regulations made under the Act require the Council to make available for public inspection submissions received in accordance with Section 223 during the previous 12 months.

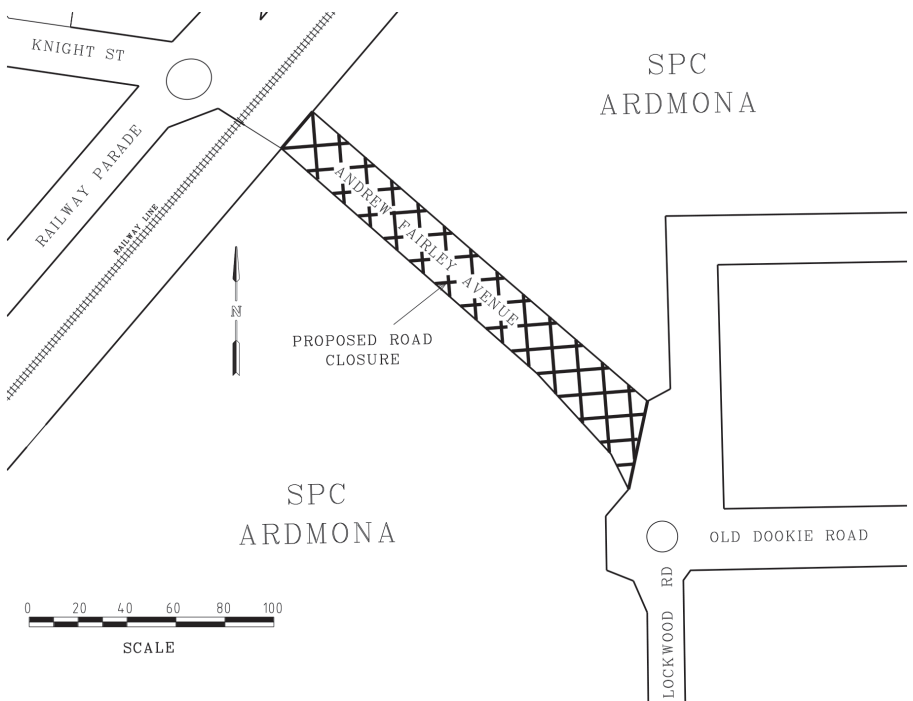
Any person making a submission is entitled to request in the submission that the person wishes to appear in person, or to be represented by a person specified in the submission, at a meeting to be heard in support of that submission.

Where a person wishes to be heard by Council or appointed committee they must advise of such in their written submission. The time, date and location of the meeting to hear verbal submissions is set out below.

Submissions should be marked “proposed discontinuance of part of Andrew Fairley Avenue, Shepparton” and addressed to Council’s Chief Executive Officer.

All such previous submitters who can be identified by Council will be notified of this and can also make a submission in response to this notice, if they wish, but are not obliged to do so.
- Any previous submitter who requested to appear or to be represented by a person specified in his or her submission in response to the Prior Notice will be given an opportunity to appear at the meeting set out below.
