#### RECOMMENDATION

**That the Council endorse Cr Dobson as the representative of Greater Shepparton City Council, to move the following motion at the Murray Darling Association Annual General Meeting:**

***“That the Murray Darling Association support a process to promote greater representation of First Nations people in local government and in water policy”.***

#### Executive Summary

Greater Shepparton City Council has been a member of the Murray Darling Association (MDA) since 2012. The purpose of the Murray Darling Association is to provide effective representation of local government and communities at state and federal level in the management of Basin resources by providing information, facilitating debate and seeking to influence Government policy. In the last six years, Council’s participation and leadership in Region 2 has accelerated, influencing the knowledge and direction of the Association to ensure community and environmental outcomes are achieved.

The recommendation in this report extends that level of influence to incorporate recognition of the Murray Darling Basin’s First Nations people’s local knowledge in land and water management and to support improved cultural, environmental, social and economic outcomes for First Nations people throughout the Basin.

The recommendation is to endorse Greater Shepparton’s MDA Region 2 representative, Cr Geoff Dobson, to move the motion at the Murray Darling Basin Annual General Meeting being held on Wednesday 19 May in Wentworth.

## Report Detail

The Murray Darling Association (MDA) is the peak body for local government in the Murray Darling Basin, forming policy and contributing local knowledge and regional solutions since 1944. There are currently 167 councils over four states, a large percentage of these are members of the MDA. The Association has 12 regions, meeting four times per year and consisting of Councillor representatives.

Greater Shepparton is part of Region 2, along with the following Councils:

- Federation Council (Chair)
- Berrigan Shire Council
- Edward River Council
- Moira Shire Council.

Following on from former Cr Dennis Patterson's leadership, Cr Dobson is now representing Greater Shepparton City Council in Region 2.

The 77<sup>th</sup> MDA conference and Annual General Meeting will be held 16 – 19 May in Wentworth. Cr Dobson will attend and is seeking to have Council endorsement to move Motion 5.10 First Nations Representation in Local Government with the recommendation *"That the Murray Darling Association support a process to promote greater representation of First Nations people in local government and in water policy"*.

The objective of the motion is:

- To support improved social, economic, environmental and cultural outcomes in the Murray Darling Basin by supporting First Nations people to have a greater role in the decision making process.
- To ensure local knowledge informs our national priorities.

Across the Murray Darling Basin there are 40 Aboriginal nations with an extensive history of land and water management. Since the arrival of Europeans and expanded land acquisition across the Basin, these management techniques have been declining or completely absent. Calls for Indigenous voices have been made over this time, supported nationally most recently through the Uluru Statement from the Heart.

The motion also recognises local government have a central role to play in this, it is this level of government that most directly reflects the aspirations, concerns and needs of our communities. Local government has long been a leadership model for significant and lasting change for our communities. Recent examples in Greater Shepparton are the response to the COVID, climate and biodiversity emergencies we are facing.

The graduates of the Murray Darling Association Basin Communities Leadership Program developed the motion in consultation with, and with the approval of, the Northern Basins Aboriginal Nations and Murray Lower Darling Indigenous Nations in Cunnamulla in 2021. Cr Geoff Dobson is seeking to move this motion at the MDA Annual General Meeting, and Cr Greg James, Greater Shepparton City Council's first Indigenous Councillor will connect with the conference via electronic means to speak to the Motion.

This motion is supported in the MDA Strategic Plan 2020-25 in pillar 3, ref 3.5.3 - *First Nations culture is reflected in and supported by MDA policy and position statements.*

Murray Darling Association Basin Communities Leadership Program developed this motion in consultation with, and approval of, the Northern Basins Aboriginal Nations and Murray Lower Darling Indigenous Nations.

Officers believe that appropriate consultation has occurred and the matter is now ready for Council consideration.
