1. Failure to clearly display a valid parking permit on the dashboard of the vehicle will result in a parking infringement notice being issued.
2. Council does not guarantee that a parking bay will be available when required.
3. Council will issue a maximum of one (1) permit per application. A permit entitles the holder and nominated vehicle to park for unlimited periods in the nominated car park. Permits are not transferable and cannot be used by other drivers.
4. Permission to use the parking bay can be revoked at any time by a member of Victoria Police, or by an authorised officer of the Council.
5. The applicant must nominate one desired parking location area A, B, C, D or E as indicated on this application. Permits are not valid in any other location.
6. Vehicles must be legally parked at all times in accordance with the Road Rules Regulations 2017.
